

LIFETIME ISA

Matured Child Trust Fund to Lifetime ISA transfer form

This form lets you transfer a matured Child Trust Fund (CTF) to a Lifetime ISA with AJ Bell Youinvest.

If you don't already have an AJ Bell Youinvest Lifetime ISA you'll need to apply for one using our online application process before completing this form.

If you want to transfer a matured CTF to a Stocks and shares ISA, don't complete this form – instead complete the 'Matured Child Trust Fund to ISA transfer form'.

You can only transfer cash (not investments) from a matured CTF to your AJ Bell Youinvest Lifetime ISA, and the maximum you can transfer is the annual Lifetime ISA allowance of £4,000. But this will be reduced if you've made payments to your Lifetime ISA (or transferred in from other types of ISA) this tax year. You are only allowed to pay into one Lifetime ISA each tax year.

Once the transfer from your matured CTF is complete, you can withdraw money free of charge once you've reached age 60, if you're buying your first home, or if you're terminally ill. If you withdraw under any other circumstances, you will pay a government withdrawal charge of 25% - which could mean you get back less than you put in.
